**Sub: Equivalence of Grade 10 and 12 Board Examination/Qualification/Courses conducted by the Maharshi Sandipani Rashtriya Veda Sanskrit Shiksha Board (MSRVSSB), under Maharshi Sandipani Rashtriya Ved Vidya Pratisthan (MSRVVP), Ujjain with Examination/Qualification/Courses conducted by other Central/State School Boards of India for the purpose of admission in higher education institutions and employment in Central/State Government organizations/bodies.**

Sir/Madam,

I am directed to refer to this Ministry's letters of even number dated 8<sup>th</sup> August, 2022 (copy enclosed) on the subject mentioned above wherein it has been conveyed that Maharshi Sandipani Rashtriya Veda Sanskrit Shiksha Board (MSRVSSB), Ujjain has been recognized as a regular school board by the Govt. of India. Further, the Govt. of India has also recognized the certificates i.e. Ved Bhushan and Ved Vibhushan issued by it equivalent to 10<sup>th</sup> & 12<sup>th</sup> standard respectively. It was also requested therein to issue necessary instructions to all concerned for safeguarding the interest of the Veda students.

2. In this regard, it has been brought to the notice of the Government that the pass out students of Veda Bhushan (10<sup>th</sup>) and Veda Vibhushan (12<sup>th</sup>) from the MSRVSS Board are continuously facing difficulties in getting admissions in the higher Educational institutions to join various courses in the Universities, registration

in the Employment exchanges for the purpose of employment and entry into government services, particularly in the Ministry of Defence (for the post of Dharma Guru in the Military Services), and in the Ministry of Railways (for Recruitment by the Railway Board) and by the other recruiting agencies such as the Staff Selection Commission of India etc.

3. It is reiterated that Ministry of Education, Government of India, recognizes the **Maharshi Sandipani Rashtriya Ved Sanskrit Shiksha Board (MSRVSSB)** as a Regular School Board and certificates of two courses i.e. **Veda Bhushan** and **Veda Vibhushan**, offered by it are as equivalence to 10<sup>th</sup> & 12<sup>th</sup> standard respectively.

4. In view of the above, it is again requested to issue necessary instructions to all the concerned regarding the recognition of the certificates awarded by the MSRVVP Board and safeguard the Interests of the students of MSRVVP Board. It is also requested to include the MSRVSS Board in the portal of NTA (for appearing in CUET and other examinations) and Student Admission Management System (SAMS) of various State Authorities/Samarth E-Govt. Suite of University of Delhi.
