
Subject : Equivalence of Grade 10 and 12 Board Examination/Qualification/Courses conducted by the Maharshi Sandipani Rashtriya Veda Sanskrit Shiksha Board (MSRVSSB), under Maharshi Sandipani Rashtriya Ved Vidya Pratisthan (MSRVVP), Ujjain with Examination/Qualification/Courses conducted by other Central/State School Boards of India for the purpose of admission in higher education institutions and employment in Central/State Government organizations/bodies.

The undersigned is directed to refer to the subject mentioned above and to say that Maharshi Sandipani Rashtriya Ved Vidya Pratisthan (MSRVVP) has set up a Board in the name "Maharshi Sandipani Rashtriya Veda Sanskrit Shiksha Board (MSRVSSB)" under Rule 14(iv)(f) of the Rules under the MOA of MSRVVP. Department of School Education and Literacy, in consultation with NCERT, have concurred with the various Bye-laws and Statutory requirements for the Board. Accordingly, MSRVVP was advised to apply to the Association of Indian Universities (AIU) which is the body designated by the Government of India for according equivalence to school Boards in India, for granting equivalence to the Veda Bhushan (Class X) and Veda Vibhushan (Class XII) course being conducted by them

2. Association of Indian Universities (AIU), vide their letter No.AIU/EV/IN(I)/2022/MSRVSSB dated 3rd August, 2022, has accorded equivalence for Grade 10 and Grade 12 Board examination qualifications of Maharshi Sandipani Rashtriya Veda Sanskrit Shiksha Board (MSRVSSB) that shall function as a regular school Board within India.

3. In view of the above, the Ministry of Education, Government of India, hereby recognizes the Maharshi Sandipani Rashtriya Ved Sanskrit Shiksha Board (MSRVSSB) as a Regular School Board. Accordingly, the Certificates awarded by the MSRVSSB are equivalent to certificates issued by other Central/State School Boards of India for the purpose of admission in higher education institutions and employment in Central/State Government organizations/bodies situated in the country as under:-
