GUIDELINES FOR CELEBRATION OF VEDA GYAN SAPTAH

The *Veda Gyan Saptah* should be celebrated for full one week starting from the Makara Sankranti or Akshya Tritiya or Vasant Panchmi or Rishi Panchami or Vijaya Dashmi Day or any other auspicious week as may be determined by the convener depending upon the local circumstances. It should be organized under the auspices of renowned Vedic Institutions or scholars in the cities of all over India. The scholar will be the convener-cum-organizer of the *Veda Gyan Saptah*. The convener will form an organizing committee consisting of 7 prominent persons of the city or nearby places for the celebration of the *Veda Gyan Saptah*. Suitable financial assistance will be provided by the *Maharshi Sandipani Rashtriya Veda Vidya Pratishthan* for this purpose directly to the convener or the Vedic Institution. The amount of financial assistance admissible for this purpose is given in the concluding paragraph.

2. Under-mentioned activities are suggested to be undertaken during this week

- 1- Prabhat Pheries or Shobha Yatras, as may be directed by the convener depending upon the local circumstances, should be arranged through main street/roads of the concerned city. The details for this should be worked out by the convener in consultation with the local organizing committee.
- 2- At least seven lectures should be organized in different parts of the city. The lectures should be delivered by eminent Vedic scholars in the language which is spoken and understood by the common man in the area. These lectures should not be specialized in character but should be ~~of utility to the general public. The venues for delivering the lectures~~ should be selected in such a way that the largest gathering is attracted. The following topics are suggested for these lectures: (The convener may also

choose any other suitable subject connected with *Veda*, which may be of general interest, for the purpose of the lectures).

TOPICS

3- Exhibitions through paintings, charts models etc. should be arranged. The exhibits should highlight some of the knowledge of physical sciences enshrined in the *Vedas* or should contain memorable sayings preserved in the Vedic literature. The charts should also be given description in English and regional language of the city where the week is celebrated. The charts may also show the instruments used in the Vedic period for performing sacrifices.

4- On this occasion, suitable messages should be relayed on the All- India Radio and Door-Darshan Network from the Chairman of the *Maharshi Sandipani Rashtriya Veda Vidya Pratishthan* (Union Minister for Human Resource Development), Prime Minister and the President of India.

5- Arrangements should also be made for relaying Vedic say (वेदों के वाक्य) in between the News Bulletins and other programmes on the AIR and Door-Darshan Net-work. Likewise, sayings from the *Vedas* should also be relayed on the AIR and Door-Darshan National Net-Work programme under the caption "Thought for to-day" (आज के विचार)

6- A competition of recitation of "Vedic Suktas/ Mantras" should also be held and prizes should be given to those who stand first, second and third in the

competition. The competition should be open to all students without the requirement of any specific qualification on their part.

7- One Vedic scholar should be honored during the week at a function to be organised at a prominent place in the city. The scholar so honour may be provided with a Prashasti Patra, a Shawl and Rs.2,100/- in cash. The name and bio-data of the scholar to be honored should be sent in advance to the M.S.R.V.V.P. for this purpose and prior approval of the *Pratishthan* should be obtained for honoring the particular scholar.

FINANCIAL REQUIREMENTS:

75 percent of the expenditure to be incurred for Organising the *Vedic Gyan Saptah* will be met by the *Maharshi Sandipani Rashtiya Veda Vidya Pratishthan* and the balance of 25 percent expenditure will be met by the convener and the organizing committees by raising local donations or from their own resources. The expenditure admissible for various items will be restricted as follows:

- (1) For Prabhat Pheries / Shobha Yatras, **Rs.4,300/-** will be admissible.
- (2) For lectures, a sum for **Rs.7,700/-** will be admissible out of which Rs.1,100/- will be given as honorarium to each lecturer.
- (3) The arrangement for relaying messages/ saying etc. through AIR / Doordarshan would be made centrally by the Pratishthan itself.
- (4) Publication of M.S.R.V.V.P. (for giving Prize & gift etc.) **Rs.7,000/-**
- (5) For honoring the Vedic scholars, a grant of **Rs.3000/-** will be admissible. T.A./D/A of the scholar will also be met from this amount if the scholar has to travel for receiving the honor.

(6) A lump sum grant of **Rs.8,000/-** per institution/convener will be admissible for organizing exhibition and to meet various needed expenses during the week. All the expenses are to be supported by proper bills. The account is to be submitted to this office after conducting this program within **15 days.**
