Affiliation of Veda Pathshalas/Guru Shishya Parampara Units financially aided by Maharshi Sandipani Rashtriya Vedavidya Pratishthan and Maharshi Sandipani Rashtriya Veda Sanskrit Shiksha Board (from September, 2024 to August, 2025)-Reg.

As per terms and conditions of approval of the Ministry of Education, Government of India, affiliation of Veda students studying in Veda Pathshalas/GSP Units financially aided by the Pratishthan is mandatory for recognition of their examination of Veda Bhushan First to Fifth Year (Class-6th to 10th) and Veda Vibhushan First & Second Year (Class-11th & 12th).

In this regard, it was decided by the Maharshi Sandipani Rashtriya Veda Sanskrit Shiksha Board, Ujjain, in its first meeting that affiliation for the Academic Session 2024-25 will be provided by Maharshi Sandipani Rashtriya Vedavidya Pratishthan for students of Veda Bhushan First to Fourth Year (Class- 6th to 9th) and Veda Vibhushan First Year (Class-11th) studying in Veda Pathshalas/Guru Shishya Parampara Units Scheme financially aided by the Pratishthan and affiliation of students of Veda Bhushan Fifth Year (Class-10th) and Veda Vibhushan Second Year (Class-12th) will be provided by Maharshi Sandipani Rashtriya Veda Sanskrit Shiksha Board.

Veda Pathshalas/GSP Units that are financially aided by the Pratishthan are required to pay the annual fee in order to get affiliation for the Academic Session 2024-25, from Maharshi Sandipani Rashtriya Vedavidya Pratishthan and Maharshi Sandipani Rashtriya Veda Sanskrit Shiksha Board.
