Sub: Samparikshan for selection of Veda Teachers against vacant positions in the financially assisted Veda Vidyalayas/Guru-Shishya Parampara Units under the scheme of the Pratishthan for promotion and propagation of Saswara Veda.

1. The Maharshi Sandipani Rashtriya Vedavidya Pratishthan, Ujjain will conduct Samparikshan on **17.07.2026** at its premises for preparing a panel for engagement of new Veda teachers of any Shakha of the four Vedas, on honorarium basis, against vacant positions arising out of quitting the service by Veda teachers in these financially assisted Veda Vidyalayas functioning under the scheme of the Pratishthan. Further, the Samparikshan will also be conducted to fill vacant positions arising in the Guru-Shishya Parampara (GSP) Units where the Veda teacher has vacated the position by leaving the GSP Unit.

2. After the Samparikshan, eligible candidates may, with the concurrence of the management of the Veda Vidyalaya or Guru-Shishya Parampara (GSP) Unit concerned, be engaged for teaching arrangement on honorarium basis against the vacant positions available therein. This is NOT a service or employment under the Govt. of India, but only an arrangement for Veda teaching.

3. Teachers selected for Veda Pathshalas will be granted provisional approval with the concurrence of the management of the Institution. This shall not be treated as approval for any post or an appointment to any post or post based sanction. It shall merely be a teaching arrangement, which may be discontinued at any time without assigning any reason whatsoever.

4. If the selected candidate is not engaged by the Veda Pathshala concerned for teaching, such selection shall be deemed to have been cancelled automatically. A candidate selected for a Guru-Shishya Parampara (GSP) Unit shall be required to report to and assume charge of the assigned GSP Unit and commence its functioning within 10 days from the date of nomination. Failure to do so shall result in the selection being deemed to have been cancelled automatically and no honorarium shall be released.

5. The grant will be released subject to continued Saswara Veda teaching with complete dedication to the prescribed number of students at the said place by the Veda teacher and also he remains free from any dispute or controversy. The terms and conditions of the Veda Pathshala/Guru-Shishya Parampara (GSP) Unit Scheme, as amended from time to time, shall be applicable.

6. The teachers of the Veda Pathshala shall remain employees of the management of the Veda Pathshala concerned. They shall NOT be considered employees of the Pratishthan or the Government of India under any circumstances, nor shall they be appointed to any post under the Pratishthan or the Government of India, whether on a permanent or temporary basis. Any request for change of place of posting or transfer after selection will NOT be entertained under any circumstances.

7. The maximum number of candidates to be selected in each Shakha will be ten (10). The selected candidates may be nominated for engagement against positions in any affiliated and financially aided Veda Pathshala or Guru-Shishya Parampara (GSP) Unit located anywhere in the country. The selection will remain valid only up to 31.03.2027 and will automatically lapse thereafter.

Minimum Age	- 21 years
Educational Qualification	- Complete memorization of the Samhita with proper Vedic intonation (Saswara), comprehensive study of the Veda, proficiency in Prakriti Patha and, wherever feasible, the Ashta Vikritis. Preference will be given to candidates possessing the Veda Vibhushan Certificate and having the entire Veda Shakha memorized.
Experience	- Candidates possessing two (02) years' experience in Veda teaching will be given preference.
Honorarium as per rules of Pratishthan	- Rs. 27,500/- per month (in Veda Pathshalas) - Rs. 25,000/- per month (in GSP Units)


