Expression of Interest

Expression of Interest (EOI) is invited from Societies / Trusts / Company incorporated under Companies Act, 2013, (hereinafter called as Sponsoring Body), for setting up Bharatiya Shiksha Board whose function shall be to standardise Indian Traditional Knowledge, blend with modern education by way of forming syllabus , conducting examination, affiliating and recognising different forms of schools, issuing certificates of Indian Traditional Knowledge / Indian Traditional Knowledge blended with modern education up to senior Secondary level. The Board is expected to be set up by a not-for-profit Society by the selected agency. The Bharatiya Shiksha Board Society is to be set up as per the model bye-laws available on the website of MSRVVP <http://msrvvp.ac.in/>. After selecting the agency for setting up the Board, the MSRVVP will issue the order with due approval of Government.

A. Eligibility Conditions for submission of the Expression of Interest:

1. The Sponsoring Body should be involved in preservation, conservation, promotion and propagation of Indian Traditional Knowledge which includes Vedic education, Sanskrit education, Yoga in schools for at least five years and there should be a credible evidence for this.
2. The Sponsoring Body should be in existence for atleast ten years.
3. The net worth of the **Sponsoring Body should not be less than Rupees three hundred crore** for last three consecutive years, which should be evidenced through credible documents.
4. The Sponsoring Body shall be capable of forming the Bharatiya Shiksha Board Society comprising of at least eight members out of which credentials of at least four members should be such that they have proven commitment in preservation, conservation, promotion of Indian Traditional Knowledge specially in Vedic education, Sanskrit education, yoga for at least five years.
5. The Sponsoring Society should have atleast three reputed and credible individuals who have contributed to education and other public and social issues for at least ten years.
6. The Sponsoring Body and Bharatiya Shiksha Board Society (Sponsoring Society) should be at arm's-length. Not more than three members from the Sponsoring Body should be members of the Sponsoring Society.
7. Minimum Corpus fund to be earmarked and promised by the Sponsoring Body to **Bharatiya Shiksha Board must not be less than Rupees fifty crore apart from some development fund.**

B. Scope of work:

1. The Sponsoring Body shall register Bharatiya Shiksha Board Society within one month from the date of confirmation by MSVVP.

2. The Society set up shall establish Bharatiya Shiksha Board within three months from the date of confirmation by MSVVP, failing which the confirmation order can be cancelled
3. The objectives and functions of the BSB so set up shall be as per the model Bye-Laws which is available on the website of MSRVVP <http://msrvvp.ac.in/>.

C. Submission of Proposals:

The Sponsoring Body should submit the proposal (soft copy to msrvvpunj@gmail.com as well as hard copy by Speed Post) in prescribed format **(Annexure-I)** by **5.00 PM on 19.02.2019** to:

The proposal should be submitted along with **processing fee of Rupees twenty lakhs in the form of demand Draft Payable** to Secretary, MSRVVP, Ujjain which shall be **non refundable**.

D. Selection procedure: The MSRVVP will select suitable agency for setting up the BSB in two stages as follows.

First Stage

1. There shall be an Expert Committee comprising of one Chairman and four members formed by Governing Council of MSRVVP.
2. The Expert Committee will examine, evaluate all the proposals based on the following:
 - a) Will examine all the applications with reference to eligibility of Sponsoring Body.
 - b) Credibility and Experience of Sponsoring Body and members of Sponsoring Body and persons proposed to be members of Bharatiya Shiksha Board Society to the cause of Education in the field of Vedic education, Sanskrit education, yoga or Indian Traditional Knowledge.
 - c) Time lines proposed by Sponsoring Body for establishment and operationalization of Bharatiya Shiksha Board.
 - d) Corpus fund to be promised through Bank Guarantee to Bharatiya Shiksha Board
 - e) Availability of infrastructural resources like land and buildings for establishment of Bharatiya Shiksha Board.

3. Based on above scrutiny and evaluation of proposals the committee will shortlist the eligible Sponsoring Bodies.

Second stage:

1. The Expert Committee will rank all the eligible and capable Sponsoring Bodies **in the order of development fund promised** through Bank Guarantee by the Sponsoring Bodies.
2. The Expert committee will recommend the top three Sponsoring Bodies to Secretary MSRVVP for obtaining approval of the Governing Council of MSRVVP.
3. The Secretary, MSRVVP, will place the recommendations of Expert Committee before Governing Council of MSRVVP. The Governing Council will select one Sponsoring Body for establishment of Bharatiya Shiksha Board Society from amongst the recommended Sponsoring Body.
4. The Secretary, MSRVVP, will issue orders to Sponsoring Body for formation of Bharatiya Shiksha Board with detailed terms and conditions in consonance with the model Bye-Laws, after due approval of Government.
