

**OFFICE ORDER**

**Subject: Acceptance of Resignation of Dr Mithilesh Kumar Pandey, RAVV Atharvaveda Teacher.**


On 21.03.2026 afternoon, at around 3.11 p.m. a video on the incident in RAVV Students' Hostel, Ujjain, circulating on social media was brought to my notice. Immediately all RAVV teachers were called by me to ascertain the veracity of the video and date and time of such video. Prima facie, it was revealed from video itself that the video was shot on 15-03-2026 at 10.07 PM. It is recalled that the undersigned was away on official tour from 5.00 AM on 10-3-2026 to 4.30 PM on 19-3-2026. (14 and 15 Saturday and Sunday) and NONE of the persons (1 hostel-guard, 6 internees-Svadhyaya sahayaks) witnessing the incident reported the matter to any of the Assistant Directors in office or to the Secretary who was away on tour on 16-3-2026 or on his return to MSRVVP on 19-3-2026 or till 20-03-2026. The video came to the notice of the undersigned only on 21.03.2026 afternoon, at around 3.11 p.m. when the undersigned had gone for his Eye check up. The undersigned immediately returned from EYE Hospital around 3.50 PM.

2. All the RAVV teachers (including Shri Dattadas Raghunath Shevde) were called to Secretary's Chamber and were shown the video and in unequivocal terms the action of Shri Dattadas Raghunath Shevde was condemned in severest words. In the meeting it was stated by Shri Dattadas Raghunath Shevde that the alleged video was shot with mischievous intent by Shri Bheraram Sharma, an internee. On demand from Dr. Mithilesh Kumar Pandey, RAVV-Atharvaveda Teacher, the video was sent to him by Shri Bheraram. Dr. Mithilesh Pandey accepted in front of all the other teachers that he received the video from Shri Bheraram, but he deleted the video. Shri Bheraram also stated that he deleted the video immediately after sending to Dr. Mithilesh Pandey. In the presence of all Dr. Pandey denied that he forwarded the video to anybody. An investigation committee was constituted by the undersigned immediately.

3. Meanwhile, Dr Mithilesh Kumar Pandey, RAVV Atharvaveda Teacher tendered his resignation on 21-3-2026 at around 8.15 PM while the departmental investigation was being conducted and video was becoming viral. After due consideration of the letter submitted by Dr Mithilesh Kumar Pandey, RAVV Atharvaveda Teacher, the undersigned as the Competent Authority accepted the resignation of Dr Mithilesh Kumar Pandey and relieved him from his contractual service as RAVV Teacher of MSRVVP, Ujjain with immediate effect from 21.03.2026 (Saturday) evening. The honorarium dues payable to him for the month of March, 2026 up to 21.03.2026 would be adjusted for want of notice period.
