

## **Important Instructions for appearing in the Skill Test for the post of Staff Car Driver**

1. It is mandatory for the candidates shortlisted for the Skill Test to produce the original copies of all Educational Qualifications, Experience Certificates, Driving Licence, Personal Identity Proof (Aadhaar Card, PAN Card) and Caste Certificate. Candidates failing to produce the original certificates shall not be allowed to participate in the Skill Test.
2. Candidates shall be permitted to appear in the Skill Test only after verification of all their certificates. If any forged/fabricated certificate is found during the verification process, the candidature of the candidate shall be cancelled forthwith, he/she shall be debarred from appearing in the Skill Test and legal action shall be taken.
3. If any person other than the candidate called for the Skill Test on the basis of the Written Examination is found appearing in the Skill Test, the candidature of the candidate concerned shall be cancelled forthwith and he/she shall not be permitted to participate in the Skill Test. Further, a complaint shall be lodged with the police and legal action shall be initiated against the candidate concerned.
4. Candidates are instructed to report at the centre at 8:00 A.M. for the Skill Test.
5. Candidates shall be permitted to enter the campus of the Pratishthan only at the scheduled time of the Skill Test. No candidate shall be permitted to remain in the campus of the Pratishthan after completion of the Skill Test.
6. Candidates shall not be allowed to carry any electronic gadget/mobile phone/bag or any other item into the campus of Pratishthan. All personal belongings, including bags, mobile phones, electronic gadgets, etc., must be deposited with the Security Guard at the main entrance of the Pratishthan premises at the candidate's own risk. Candidates shall be frisked/searched to ensure that they are not in possession of any electronic gadget/mobile phone/or any other unauthorized material etc.
7. If a candidate is found in possession of any electronic gadget or any other wireless communication device (whether operational or switched off), his/her candidature shall be cancelled forthwith, and he/she shall be debarred from appearing in the Skill Test.
8. No TA/DA or accommodation facility will be provided to the candidates for appearing in the Skill Test / Stenography Test / Typing Test.
9. The candidates have been shortlisted by the Pratishthan for the Skill Test on the basis of their performance in the Written Examination. However, if at any stage of the selection


process any discrepancy is found with regard to a candidate's eligibility, age or any other prescribed criteria, the candidature of such candidate shall be cancelled forthwith.

10. The decision of the Selection Committee shall be final and binding on all candidates in all matters pertaining to the selection process.

11. The Pratishthan reserves the full right to revise the number of candidates shortlisted for the Written Examination/Skill Test conducted by it, to cancel or postpone the examination either wholly or partially, or to make any change whatsoever in the examination/selection process for any reason. No correspondence in this matter shall be entertained.

12. Candidates who fail to appear for the Skill Test on the scheduled date and time shall NOT be granted another opportunity under any circumstances.

13. Only the shortlisted candidates who have appeared in the written examination shall be allowed to appear in the Skill Test.
