Sub:-Installation of CCTV cameras for safety of the students in Veda Pathshalas/ GSP Units financially aided by the Pratishthan and surveillance of staff -Reg.

As per the directives of the Hon'ble Supreme Court of India, safety of the students in Educational Institutions/Hostels is a top priority. In view of the above, it is necessary to put the Vidyalayas/Hostels under surveillance through CCTV cameras. Further, a thorough identity verification of the staff members and outsourced employees working in the Vidyalayas/Hostels must be conducted prior to their engagement.

The Managements/Pradhanacharyas/GSP Unit Gurus of the financially aided Veda Pathshalas and GSP Units of the Pratishthan are, therefore, directed to ensure proper compliance of the following instructions for giving priority to the safety of the Veda students :-

- (1) **CCTV** cameras may be installed at the entrance of the Veda Pathshala/ Vidyalaya/Hostel, in different places of the campus and buildings such as inside the examination hall, outside the students' rooms, outside the washroom, etc.
- (2) A Register may be maintained at the main entrance of Vidyalaya/Hostel and names, mobile Nos., & other details of all the visitors may be recorded with time of entry and exit.
- (3) Students alone should not be allowed to go out of the Vidyalaya or Hostel campus and they must be advised not to interact with strangers or accept any food item offered by them.
- (4) Character and antecedents of the staff engaged in Vidyalaya/hostel may be got verified before engaging them to ensure that they are not involved in any criminal activities or in the company of unsocial elements, which may harm the well-being of students.
- (5) Only after installation of **CCTV** Cameras in the Vidyalaya, it will be approved as an examination centre for the Annual Examinations of Veda Bhushan and Veda Vibhushan courses conducted by the Pratishthan/MSRVSSB, Vidyalayas where CCTV cameras are not installed will be not be selected as Examination Centres.
- (6) **The examination centres for the annual examination for 2024-25 are to be selected by the Pratishthan shortly. The Veda Pathshalas/Vidyalayas should immediately install CCTV cameras at their own cost and send photographs of the CCTV cameras installed in the Vidyalaya buildings to the Pratishthan's E-mail (exam.msrvvp@gmail.com) latest by 25-11-2024. This is essential for allocation of examination centres for the Annual Examination 2024-25.**
