Sub : Submission of information and proof in respect of Remedial Classes conducted for unsuccessful students in the Examination-reg.

The examination results of Veda Bhushan Fifth Year and Veda Vibhushan Second Year for the session 2025-26 were declared by the Maharshi Sandipani Rashtriya Veda Sanskrit Shiksha Board on 21 May 2026 on the official website (<https://msrvvp.ac.in/>) of the Pratishthan. As per the examination results declared for the session 2025-26, it has been observed that the percentage of unsuccessful students during the session is approximately 30%, which is relatively high in comparison to the percentage of successful students.

In the aforesaid context, all Pathshalas/Guru-Shishya Parampara Units are hereby directed to clarify whether remedial classes are being conducted, after the declaration of examination results, for students declared unsuccessful in the examinations and required to appear in supplementary examinations or for the purpose of improving the academic level of students. In case remedial classes are being conducted, the following proof shall be submitted to the Pratishthan :

1. Copy of the timetable and attendance register pertaining to the Remedial Classes.
2. Details of the Veda Teacher(s) / Modern Subject Teacher(s) who conducted the Remedial Classes.
3. Photographs of the Remedial Classes.
4. Video recordings or CCTV footages.
5. Any other relevant proof substantiating the conduct of the Remedial Classes.

The above information and proof must be submitted to the Dealing Assistant concerned in the Academic Section of the Pratishthan, so that the academic efforts undertaken for the unsuccessful students may be examined and necessary action may be taken accordingly.
