Educational & other qualification (For Direct Recruitment)	:	i) Bachelor's Degree; ii) 2 years experience in Cash, Account and Budget work in a Government Office/ PSU/Autonomous Body/ Statutory Body.
Age limit for Direct Recruitment	:	30 years (Relaxable for Government servants up to 5 years in accordance with the instructions issued by the Central Government).


