VED BHUSHAN-I (Class - 6th) : ONLINE ADMISSION NOTIFICATION


Regarding online admission of students in the first year of Veda Bhushan on Oral Tradition of Vedic Studies in Veda Pathshalas / Guru Shishya Parampara units for the academic year 2026-27.

Maharshi Sandipani Rashtriya Veda Vidya Pratishthan, Ujjain runs 7 year course on **Oral Tradition of Vedic Studies** in all Vedas and awards certificate by name **Veda Bhushan 1-3 (Equal to Prathama) Veda Bhushan 4-5 (Equal to Purva Madhya) and Veda Vibhushan 1-2 (Equal to Uttara Madhyama)** which aim for the preservation of Shruti Parampara **Oral Tradition of Vedas**.

The Pratishthan invites online applications for admission into **first year of Veda Bhushan (Class - 6th) Course on Oral Tradition of Vedic Studies** to be run in Veda Pathshalas and Guru-Shishya Parampara Units in the academic session 2026-27. The online admission will be done by **Veda Pathshalas/Guru-Shishya Parampara units** and will be available from **15/04/2026 to 31/05/2026**.

"Non-financed units" will not be considered. However, Vitta-Poshit Veda teachers can teach Vedas up to five **non-financed** students. **There are many vacant Vittaposhit seats under each of Vitta-Poshit Veda teachers (in GSP/Pathashala). Therefore, all vacant Vittaposhit students' seats be filled up on priority basis.**

Upon admission as Vitta Poshit student and on Aadhaar authentication, MSRVVP will pay Rs. 3500 per month from Grant in Aid from Government of India for the Veda Pathathala / Guru-Shishya Parampara unit for food and accommodation- maintenance grant of each Vitta Poshit student and Rs.1500/- for each Vitta Poshit student's accounts as self-stipend. **This is further subject to physical presence of the Student in Veda Vidyalaya and in hostel/GSP residence of guru for Veda studies and availability of Budget from Government of India.**




For admission into first year Veda Bhushan in Veda Pathashalas / Guru-Shshya Parampara Units, the student will need following documents to fill up online admission form:

1. 5th standard pass marks card (Mark-sheet) and or School Leaving Certificate are compulsory and need to be uploaded after scanning. **The 5th Equivalent Certificate of reading and writing ability (Hindi / English / General Knowledge / Mathematics) will not be considered for admission to Vedbhushan First Year (Class 6th) in the academic session 2026-27,**
2. It is mandatory to attach non-mutilated date of birth certificate (Issued by Govt authority), Aadhaar card copy and marks sheet of previous examination qualified for verification.
3. The maximum age limit for admission in Veda Bhushana 1st year course is 16 years as on **June, 2026.**
4. For the admission as Vitta Poshit student, Joint Account of the student with his/her parents (Mother or father) in a nationalized bank is essential. Aadhaar no. authentication is also essential. In the absence of a Joint Account with the parent in the bank, the student is not eligible for admission as Vitta Poshit/stipend receiving student. The scanned copy of the first page of the Joint Bank A/C Passbook (where the student and Parents's photo is attached and the account number is printed) is required.
5. No donation / capitation fees/guarantee money for admission, dining and accommodation is payable to any Veda Pathathala / Guru-Shishya Parampara unit for the study of the Veda.
6. Until the admission is confirmed by the Pratishtan, all admissions done at Veda Pathathala / Guru-Shishya Parampara unit level, are provisional only. Pratishtan will not be responsible for any error by the Pathashala / GSP Unit.
7. The students studying in the Veda Pathashalas/ GSP Units financially assisted by Pratishtan are not allowed in any case to participate in any other Exam/ course being run and conducted by any other State Board / Institution/ Open Board. The Veda Pathashalas/ GSP Unit teachers affiliated with Pratishtan are not allowed to affiliate with any other Board / Institution.


Hence, all the students willing to get admission in Veda Pathshalas / Guru-Shishya Parampara unit should keep the following documents up to 40 KB size in separate-JPEG format for uploading and verification.

1. Student's latest color photograph in JPEG format
2. First page of the Joint Bank Account of the student with his/her parents (Mother or father) and the account number is clearly/visibly printed in JPEG format .
3. Standard 5th pass marks card/ marks-sheet/School Leaving Certificate or equivalent OR 5th standard Proficiency Certificate (in prescribed format) from Govt school teacher
4. Non-mutilated Date of Birth Certificate in JPEG format- Date of Birth noted in Govt Certificate will be accepted.
5. **Aadhaar card** copy in JPEG format

Admission related directions and steps for online admission in to Veda Pathashala / Guru-Shishya Parampara unit

1. The Veda Pathashala / Guru-Shishya Parampara unit teacher will fill the admission details of the students seeking admission as per the information filled up by the student / parent and get the signature of the student and parent, along with the self-certified copy of the records. Prepare the JPEG scan copy of (Educational Certificate, Birth Certificate, Joint A / C Pass Book, Aadhaar Copy) and keep them separately.
2. Using Log-in-Id, Veda Pathashala / Guru-Shishya Parampara unit teacher enter into the Pratishthan's online portal for admission.
3. According to the admission details filled up by the student / parent, should register for online admission and fill the details. Finally, "**submit**" and print the document pressing "**Print**".
4. Upon "**Submit**", the registration number will appear. Make sure to write down registration number. At later date also, by searching the registration number, you can print the admission document.
5. If there is an error while registering/ any information, the student may correct for one more time but within 24 hours by searching through registration number and correction.
6. It shall be the responsibility of the Veda Pathashala / Guru-Shishya Parampara unit teacher to complete the admission details, forms, verify their attachments and other documents provided by the student and teacher.
7. The admission form filled and enclosures attached by the student / parent should be sent by the Veda Pathashala / Guru-Shishya Parampara unit teacher to Pratishthan immediately by speed post for record.
8. Veda Pathashala can book expenditure incurred in online admission in the clerical expenditure (10%) of the contingency grant amount made available by Pratishthan.

INFORMATION

1. Sample admission application form for new student is available on Pratishtan's Website. Please download the form and practice online admission by filling the details of students as provided by student / parent.
2. The Veda Pathashala / Guru-Shishya Parampara unit teacher were given login-in-id and password in 2018 itself. Newly recognized Vittaposhit teachers has been given Login IDs.
3. The teachers of GSP who have not sent their e-mails to the Pratishtan send their e-mails instantly.
4. **"Non-financed units"** will not be considered. However, Vitta-Poshit Veda teachers can teach Vedas up to five **non-financed** students.
6. Admission is given to the Vedabhushan First Year (6th Std.) in the Veda Pathashalas / GSP Units being financially assisted by MSRVVP, Ujjain. On the basis of the performance and merit list of students in Vedabhushan -Third Year (8th Std.), students are admitted to the Veda Bhushan - Fourth Year (9th Std.) in the Rashtriya Adarsh Veda Vidyalayas (RAVVs) being run by MSRVVP, Ujjain. Veda Bhushan Fourth Year (9th Std.), Fifth Year (10th Std.) and Vedavibhushan First Year (11th Std.) , Vedavibhushan Second Year (12th Std) are allowed to study in residential RAVVs campus.

Special Notice: UDISE+ numbers have been allotted to the Vedapathshalas. The process of assigning UDISE+ numbers to units operating under the Guru-Shishya tradition is currently underway. The UDISE+ number of the respective Vedapathshala must be entered in the students' online application forms.
