### **Inviting applications for affiliation with the Pratishthan and Maharshi Sandipani Rashtriya Veda Sanskrit Shiksha Board for the Academic Session 2026-27 from Veda Pathshalas and Guru-Shishya Parampara Units receiving financial aid from Maharshi Sandipani Rashtriya Vedavidya Pratishthan– reg.**

As per the approval of Ministry of Education, Government of India, affiliation of Veda Pathshalas and Guru-Shishya Parampara Units receiving financial aid from the Pratishthan is mandatory for the recognition of the examination of students studying in (a) Veda Bhushan First Year (Class-6<sup>th</sup>) to Veda Bhushan Fifth Year (Class-10<sup>th</sup>), (b) Veda Vibhushan First Year (Class-11<sup>th</sup>) and (c) Veda Vibhushan Second Year (Class-12<sup>th</sup>).

2. In this regard, it was decided by the Maharshi Sandipani Rashtriya Veda Sanskrit Shiksha Board in its first meeting that for recognition of examinations of students studying in Veda Pathshalas and Guru-Shishya Parampara Units financially aided by the Pratishthan, affiliation in respect of (a) Veda Bhushan First Year (Class-6<sup>th</sup>) to Veda Bhushan Fourth Year (Class-9<sup>th</sup>) and (b) Veda Vibhushan First Year (Class-11<sup>th</sup>) will be provided to the Veda Pathshalas and Guru-Shishya Parampara Units by Pratishthan ; whereas, affiliation in respect of (c) Veda Bhushan Fifth Year (Class-10<sup>th</sup>) and (d) Veda Vibhushan Second Year (Class-12<sup>th</sup>) will be provided by the Board.

3. Financially aided Veda Vidyalayas / Veda Pathshalas / Educational Institutions / Guru-Shishya Parampara Units should have affiliation only with Maharshi Sandipani Rashtriya Veda Sanskrit Shiksha Board, Ujjain. If affiliated with any other Board, then affiliation with Maharshi Sandipani Rashtriya Veda Sanskrit Shiksha Board, Ujjain will be cancelled. Students will be eligible to appear in the examination conducted only by Maharshi Sandipani Rashtriya Veda Sanskrit Shiksha Board or Pratishthan.

4. The online application form for affiliation is available on the website of the Pratishthan ([www.msrvvp.ac.in](http://www.msrvvp.ac.in)). The last date for online application and fee submission is 8<sup>th</sup> June, 2026.

5. Veda Pathshala / Guru-Shishya Parampara Unit **financially aided** by the Pratishthan will have to pay Annual Fee as per the following slab applicable to it for getting affiliation from the Pratishthan and the Board for the Academic Session 2026-27:-
