VED VIBHUSHAN : ONLINE REGISTRATION NOTIFICATION

Regarding online REGISTRATION of students in the first year of Veda Vibhushan (Equal to Uttara Madhyama) on Oral Tradition of Vedic Studies in Veda Pathshalas / Guru-Shishya Parampara units for the academic year 2020-21

Maharshi Sandipani Rashtriya Veda Vidya Pratishthan, Ujjain runs 7 year course on Oral Tradition of Vedic Studies in all Vedas and awards certificate by name Veda Bhushan 1-3 (Equal to Prathama) Veda Bhushan 4-5 (Equal to Purva Madhya) and Veda Vibhushan 1-2 (Equal to Uttara Madhyama) which aim for the preservation of Shruti Parampara Oral Tradition of Vedas.

The Pratishthan invites online applications for admission into Veda Vibhushan 1-2 (Equal to Uttara Madhyama) Course on Oral Tradition of Vedic Studies to be run in Veda Pathshalas and Guru-Shishya Parampara Units in the academic session 2020-21. The online admission will be done by Veda Pathshalas / Guru-Shishya Parampara units and is available from 28 August 2020 to 10 October 2020.

"Non-financed units" will not be considered hereafter. However, Vitta-Poshit Veda teachers can teach Vedas up to five non-financed students. There are many vacant Vittaposhit seats under each of Vitta-Poshit Veda teachers (in GSP/Pathashala). Therefore, all vacant Vittaposhit students' seats be filled up on priority basis.

Upon admission as Vitta Poshit student and on Aadhaar authentication, MSRVVP will pay Rs. 3000 per month from Grant in Aid from Government of India for the Veda Pathathala / Guru-Shishya Parampara unit for food and accommodation- maintenance grant of each Vitta Poshit student and Rs.1000/- for each Vitta Poshit student's accounts as self stipend. This is further subject to physical presence of the Student in Veda Vidyalaya/GSP and availability of Budget from Government of India. The self stipend of Rs. 1000/- per month will be paid into the joint bank account of the Veda Student with parents subject to Certificate/Shapathpatra for the of study by the student through online teaching to be conducted and to be certified by Veda Guru.

For REGISTRATION into first year **Veda Vibhushan (Equal to 1st year of Uttara Madhyama)** in Veda Pathashalas / Guru-Shshya Parampara Units, the student will need following documents to fill up online admission form:

1. **Veda bhushan-5** pass marks card (Mark-sheet) need to be uploaded after scanning. Students must have passed all papers of all five years of Veda bhushan.
2. Date of Birth noted in **Veda bhushan marks card** will only be accepted. The Date of Birth noted in the Veda bhushan marks card shall not be allowed to be changed/alterd under any circumstances.
3. It is mandatory to attach Aadhaar card copy and marks sheet of previous examination qualified for verification.
4. Those students who are continuous and there is no gap from Veda-Bhushan-5 to Veda Vibhushan-1 will be allowed for registration.
5. For the admission as Vitta Poshit student, Joint Account of the student with his/her parents (Mother or father) in a nationalized bank is essential. Aadhaar authentication is also essential. In the absence of a Joint Account with the parent in the bank, the student is not eligible for admission as Vitta Poshit/stipend receiving student. The scanned copy of the first page of the Joint Bank A/C Passbook (where the student and Parents's photo is attached and the account number is printed) is required.
6. No donation / capitation fees/guarantee money for admission, dining and accommodation is payable to any Veda Pathathala / Guru-Shishya Parampara unit for the study of the Veda.
7. Until the admission is confirmed by the Pratishtan, all admissions done at Veda Pathathala / Guru-Shishya Parampara unit level, are provisional only.

Hence, all the students willing to get admission in Veda Pathshalas / Guru-Shishya Parampara unit should keep the following documents up to 40 KB size in separate-JPEG format for uploading and verification.


1. Student's latest color photograph in JPEG format
2. First page of the Joint Bank Account of the student with his/her parents (Mother or father) and the account number is clearly/visibly printed in JPEG format .
3. **Veda bhushan-5** pass marks card
4. Non-mutilated Date of Birth Certificate in JPEG format
5. **Aadhaar card** copy in JPEG format

Registration related directions and steps for online registration in to Veda Pathashala / Guru-Shishya Parampara unit for Veda Vibhushan.

1. The Veda Pathashala / Guru-Shishya Parampara unit teacher will fill the registration details of the students seeking registration as per the information filled up by the student / parent and get the signature of the student and parent, along with the self certified copy of the records. Prepare the JPEG copy through smart phone scanner of (Educational Certificate, Birth Certificate, Joint A / C Pass Book, Aadhaar Copy) and keep them separately.
2. Using Log-in-Id, Veda Pathashala / Guru-Shishya Parampara unit teacher enter into the Pratishthan's online portal for registration.
3. According to the registration details filled up by the student / parent, should register for online admission and fill the details. Finally, "submit" and print the document pressing "Print".
4. Upon "Submit", the registration number will appear. Make sure to write down registration number. At later date also, by searching the registration number, you can print the registration document.
5. If there is an error while registering/ any information, the student may correct for one more time but within 24 hours by searching through registration number and correction.
6. It shall be the responsibility of the Veda Pathashala / Guru-Shishya Parampara unit teacher to complete the Registration details, forms, verify their attachments and other documents provided by the student and teacher.
7. The registration form filled and enclosures attached by the student / parent should be sent by the Veda Pathashala / Guru-Shishya Parampara unit teacher to Pratishthan immediately for record.
8. Veda Pathashala can book expenditure incurred in online Registration in the clerical expenditure (10%) of the contingency grant amount made available by Pratishthan.
